- V. Treasurer's Report.

A. Financial Reports for November 2019 and December 2019.

Treasurer Rodgers summarized the November 2019 and December 2019 financial reports. The two largest sources of General Fund revenue in November were General Fund Interest and Real Estate Taxes. Total General Fund expenses at 39.76% were below the expected five-month rate of 41.67%. The two largest sources of General Fund revenue in December were from the Kenilworth Library District and General Fund Interest. Total General Fund expenses at 46.90% were below the expected six-month rate of 50.0%. There were no significant or unanticipated expenses for either month. There was no discussion.

B. Bills and Salaries for November 2019.

## VIII. Director's Report. (Director Auston)

A summary of Library department activities, a listing of meetings/workshops attended by the Director and staff, community engagement reports, monthly statistics, and other information were included in Attachment 5 of Agenda Binders. Director Auston highlighted activities that occurred during November and December.

- He announced that the Library has earned a 5-star rating from the Library Journal, the oldest and most respected library services publication. Director Auston summarized the output and statistical data used to determine the rating and stated that WPLD is in the top 10 of public libraries nationwide in our budget category, and one of only seven libraries in Illinois to receive five stars. Director Auston thanked the Wilmette community, the WPLD Board of Trustees and WPLD staff members. Information about the award will be on the Library website and a press release will announce the award.
- He summarized the Director's Report which included updates to the strategic plan and to various changes to several of the Library's collections. Library staff continue to promote inclusivity in the collection in both Library displays and programming. Many students are using the Library collection as well as Library meeting space during finals.
- Director Auston summarized recent personnel changes, including the announcement of a new Finance Manager, John Risko (current Assistant Finance Director for the Village of Wilmette), who will be full-time and attend Board meetings; and Betty Giorgi, Adult Services Manager, who has announced her retirement after 25 years of service. Staff are in the process of reviewing applications that have been received for this position and hope to welcome the new manager in March.

A. Finance Committee.

Committee members are trustees Rodgers (chair), Johnson, Riddle, Wolf, and McDonald (ex-officio). All committee members and Director Auston attended the December 3, 2019 meeting. Trustees will submit their policy changes to the Chair or Director for discussion at the next meeting.
