Director Auston stated that the initial agreement between the three libraries was signed in 1984 and that both the Winnetka-Northfield and the Kenilworth Boards had signed the proposed service agreement. Director Auston and trustee Rodgers answered trustee's questions regarding the service agreement. Trustee Rodgers moved approval of the Kenilworth Service Agreement for July 1, 2019 to June 30, 2023. Library drop boxes at Plaza del Lago and the Wilmette Recreation Center will include the new WPL logo and wrap design. Drop boxes in the WPL parking lot will also include the new logo following completion of the outdoor renovation project.
